Directions to the Boston Hills BBQ Fest:

From the East: Interstate 90 West to 219 South, Exit Route 391 Boston/Hamburg, Turn Left and travel South to 8500 Boston State Road, Boston, NY 14025

From The West: Interstate 90 East to Exit 57/Route 75 Hamburg. Take Route 75/Camp Road South to Main Street, take Left and follow straight through Hamburg. Main Street turns into Boston State Road. Continue to 8500 Boston State Road, Boston, NY 14025.

From The South: US 219 North to Rice Road/Colden Exit. Turn Right and follow hill down to the stop sign. Turn Left on Boston State Road. Continue North to 8500 Boston State Road, Boston, NY 14025.

From Canada: Cross into the US at Queenston/Lewiston, Rainbow, or Peace Bridge. Follow Interstate 190 South to 90 West. Interstate 90 West to 219 South, Exit Route 391 Boston/Hamburg, Turn Left and travel South to 8500 Boston State Road, Boston, NY 14025
